Liability Information

I understand and agree that:

This release is intended to discharge in advance the Maker Faire Orange County, OCreate LLC and OCFEC, its officers, employees and agents from and against any and all liability, except for their sole negligence or intentional acts, connected in any way with the participation of myself or my minor children in activities.

The described activity may be of hazardous, strenuous, and/or physical nature.

Participation in the described activity may potentially result in bodily injury, personal injury, sickness, disease, death or property loss or damage, arising from the use and handling of tools and/or materials, among other activities.

Knowing the risk involved, nevertheless, I voluntarily request permission for myself or minor child or dependent adult to participate in the described activity.

I hereby assume any and all risks of injury, death or property damage and to release and hold harmless the Maker Faire Orange County, OCreate LLC and OCFEC, its officers, employees & agents, except for their sole negligence or intentional acts.

This waiver, release and assumption of risk are to be binding on the heirs and assigns.

I will indemnify and hold the Maker Faire Orange County, OCreate LLC and, OCFEC harmless from any loss, liability, damage, cost or expense, including litigation, which they may incur as a result of any injury and/or property damage which myself or my minor children or dependent adult may sustain while participating in said activities.
